### “The Revolution in Eyewitness Identification Research and Implications for Policy and Expert Testimony”

*Guest Speaker:*

**Professor Steven E. Clark**

Steven E. Clark is a Professor of Psychology, Director of the Presley Center for Crime and Justice Studies at the University of California, Riverside, and the founding Director of the University of California Consortium on Social Science and Law. His research focuses on procedural justice, eyewitness memory, and the role of eyewitnesses in the criminal justice system. Professor Clark has over 50 publications and has been funded by the National Science Foundation and the National Institute of Child Health and Human Development.

Much of the “settled science” in eyewitness identification research has become profoundly unsettled in the last five years. The field is rethinking fundamental questions about how to assess accuracy, how to conduct identification procedures, and how identification evidence should be considered by the courts. This “revolution” in the research has important implications for criminal justice policy, police procedures, jury instructions, and expert testimony.

Professor Clark has presented his research at national and international conferences and has also conducted seminars, workshops, and scientific presentations at the National Academy of Science, the National Science Foundation, the National District Attorneys Association, the National Criminal Defense Lawyers Association, the U.S. Attorney's Office, the Ontario (Canada) Crown (Prosecutors) Conference, and the National Meeting on Science, Technology and Law.
